Remarks (if any):

- 1. As the Bank is incorporated in the People's Republic of China, the concept of "authorised share capital" is not applicable. The information shown as "authorised share capital" in section I above refers to the "issued share capital" of the Bank.
- 2. Calculated by multiplying the total number of Offshore Preference Shares issued by the issuance price of each Offshore Preference Share, being U.S.\$20 each.
- 3. The initial conversion price, i.e. HK\$5.38 per H Share, is equal to the average trading price of the H Shares of the Bank for the 20 trading days preceding 27 March 2017, the date of announcement of passing of the Board resolution in which the issuance plan for the Offshore Preference Share is considered and approved. The number of H Shares issuable upon full conversion of the Offshore Preference Shares is equal to the aggregate liquidation preference of all the Offshore Preference Shares (being U.S.\$20 each, as converted into Hong Kong dollars at the fixed exchange rate of U.S.\$1.00 to HK\$7.7675) divided by the initial conversion price rounded down to the nearest whole number of H Shares.
